CONTEXT

It is important to have inclusive Higher Education institutions for refugees and other beneficiaries of international protection. Therefore, it is relevant to identify good practices, as well as to design and implement guidelines and strategies that will assist in raising awareness for this topic and in developing intercultural skills within the academic community, so that, ultimately, refugees and other beneficiaries of international protection feel welcome in those institutions.

AIMS

- To raise awareness among the academic community on the inclusion of refugees and other beneficiaries of international protection within the Higher Education institutions.
- To work closely with Higher Education staff, both academic and administrative, as well as Higher Education students, refugee (and other beneficiaries of international protection) students and policy makers, by sharing with them specific instruments, knowledge and skills in order to develop their social responsibility and to empower them as important actors in the shaping of a more inclusive Higher Education environment.
